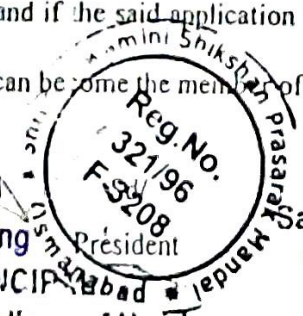


- 1) **Definition**

- Vice President** :- Hereinafter the Vice President of Shri Kulswamini Shikshan Prasarak Mandal, Osmanabad Tq & Dist. Osmanabad of Vice President of this Trust.
- Secretary** :- Hereinafter the Secretary of Shri Kulswamini Shikshan Prasarak Mandal, Osmanabad Tq & Dist. Osmanabad of Secretary of this Trust.
- Treasurer** :- Hereinafter the Treasurer of Shri Kulswamini Shikshan Prasarak Mandal, Osmanabad Tq & Dist. Osmanabad of Treasurer of this Trust.
- Member** :- Hereinafter the Member of Shri Kulswamini Shikshan Prasarak Mandal, Osmanabad Tq & Dist. Osmanabad of Member of this Trust.

- 2) **Area of Operation of the Trust** :- The area of operation of the Trust will be within the State of Maharashtra.

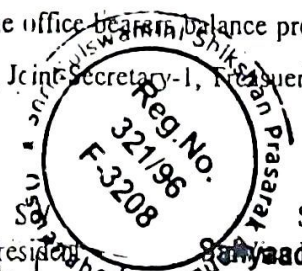
- 8) Notice of General Body and Quorum for General Body :-

- 10) Executive Committee and it's Office bearers :-

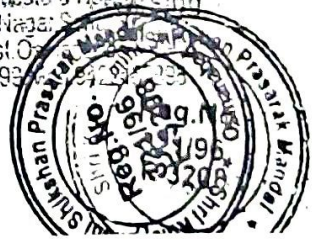

12) Officer bearers of the executive committee and their duties :-

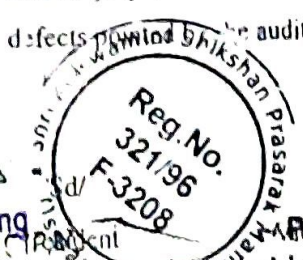
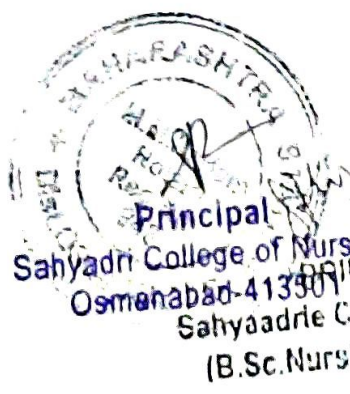
1) President :-

6) Member :-

13) The meeting of the executive committees & meeting on call :-

15) The rules and regulation for the election of the executive committee :-

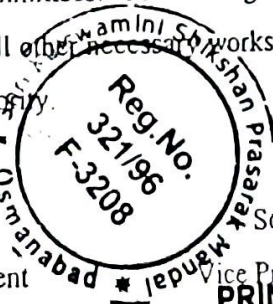
